- The index is designed to accurately represent the small-cap value segment of the U.S. equity market and deliver low turnover.

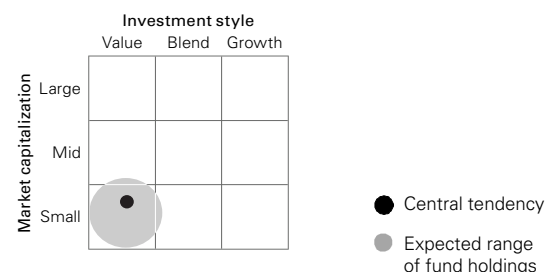

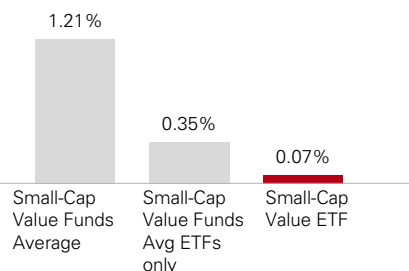
